



## PRACTICAL INFORMATION

Estetika takes place 1-2-3 April 2023 in halls 6 & 7 at Brussels Expo, Belgiëplein 1 – 1020 Brussels.

### 1. Construction & dismantling

Attention: The Low Emission Zone (LEZ) is applied in Brussels since 1 January 2018. This measure prohibits certain vehicles to drive in Brussels. More information on [www.brussels.be/lez](http://www.brussels.be/lez)

#### Construction period :

- Thursday 30<sup>th</sup> March 2023 : from 6.00 a.m. until 10.00 p.m.
- Friday 31<sup>st</sup> March 2023 : from 6.00 a.m. until 10.00 p.m.

*Exhibitors subscribing with a build-up stand, can equip the stand on Friday 31<sup>st</sup> March from 6.00 a.m.*

#### Access vehicles :

- via gate D1 : Avenue de Miramar (in front of Hall 7)
- or via gate G : Chaussée Romaine (under the footbridge)



#### Dismantling period :

- Monday 3<sup>rd</sup> April 2023 : from 5.30 p.m. until 10.00 p.m. (DISMANTLING IN CONVOY)  
The dismantling of the stands on Monday will be in convoy between 5.30 p.m. and 6.30 p.m. from parking C. All vehicles will be guided via gate G per hall inside the fence and this under police escort. Further information about the procedure will be communicated in due time.
- Tuesday 4<sup>th</sup> April 2023 : from 6.00 a.m. until 2.00 p.m. via gate D1

The halls should be evacuated on Tuesday 4<sup>th</sup> April at 3.00 p.m. at the latest.



## **2. Opening hours (for visitors)**

- Saturday 1<sup>st</sup> April 2023 : from 10 a.m. until 6 p.m.
- Sunday 2<sup>nd</sup> April 2023 : from 10 a.m. until 6 p.m.
- Monday 3<sup>rd</sup> April 2023 : from 10 a.m. until 5 p.m.

During the 3 days of the fair exhibitors can enter the hall from 8 a.m. upon presentation of their 'exhibitor' badge.

## **3. Supplying the stand during the fair**

During the fair period the exhibitor can supply his stand between 8 a.m. and 9.30 a.m. via gate D1. After 9.30 a.m. no vehicles may be parked between the halls.

## **4. Storage and empty crates**

### **STORAGE**

Ziegler has warehouses at the Exhibition Centre where your goods can be stored before and after the fair.

Goods will be delivered to and retrieved from your stand by appointment.

Please indicate beforehand the arrival and departure of goods that are stored.

### **EMPTY PACKAGING**

ZIEGLER has been entrusted with the task of storing empty packaging. No packaging may be stored in the halls during the opening of the fair. Packaging may not obstruct hallways during the assembling and dismantling of the hallways.

You are requested to pick up the yellow identification stickers, which are to be affixed on your packaging, from the ZIEGLER office. The empty packaging will be delivered back to the stands during the night following the closing of the fair.

The services provided by ZIEGLER will be charged at the officially fixed rates for the fair.

The exhibitor/official stand holder is responsible for paying ZIEGLER for all shipping and handling carried out for exhibitors and subcontractors who were present at his stand.

Goods and packaging on the stands are at the exhibitor's risk.
